Limited Warranty

This product is warranted to be free of defects in material and workmanship for a period of six (6) months from the date of original purchase. ThermoPore will, at its option, repair or replace without charge, except for transportation costs, parts that fail under normal use and service when operated and maintained in accordance with our instructions. This warranty does not cover damage caused by misuse, abuse, or unauthorized modifications. Proof of purchase is required to verify eligibility.

Use For: Solids such as those from processing materials, coal, iron, ore, flour, and certain other substances. Liquids or non-oil based dissolved particles from sprays that do not also emit oil aerosols or vapors.

Do Not Use: Gases and vapors, including those present in paint spraying operations oil aerosols, asbestos, or sandblasting.



Hold the respirator in hand with the nosepiece at your fingertips, allowing the headbands to hang freely below your hand.



Press the respirator firmly against your face with the nosepiece on the bridge of your nose.



Stretch and position the top band high on the back of your head. Stretch the bottom band over the head and position below your ears.



Using both hands, mold the nose piece to the shape of your nose.

To test fit: Cup both hands over the respirator being careful not to disturb position, and inhale aggressively. If air leaks around edges, reposition the straps of adjust tension for better fit. Follow these instructions during each use to achieve proper fit.



Wearer must read fitting and use limitations before use.
